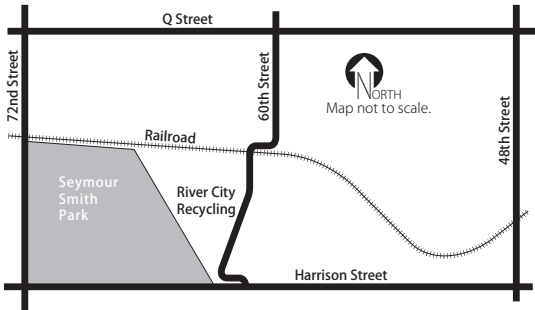

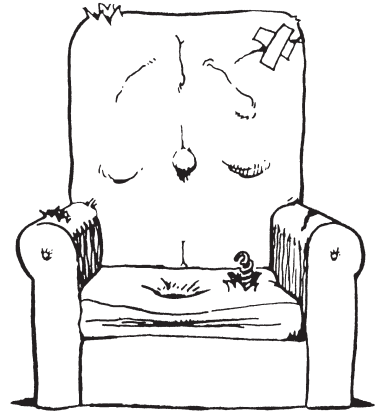

City of Omaha Bulky Material Disposal Program 2021

The City of Omaha bulky material disposal program is offered to all residents within the city limits of Omaha. The City has a contract with River City Recycling to receive bulky waste at subsidized prices. There is no city program for collecting bulky items from households since these materials are prohibited from Omaha's regular collection.

Limitations & Requirements

Before proceeding to River City Recycling and Transfer Station, **be aware that your home must be located within the city limits of Omaha.**

At River City Recycling and Transfer Station **state that you want to participate in the City's cost share program**, and then you will need to provide proof of residency that shows your street address not a Post Office Box by any two of these means where the addresses of the two items match:

- ▶ Vehicle registration
- ▶ State Issued ID (driver's license, state ID card, CHP permit, military ID)
- ▶ Residential Utility Bill (gas, water, electricity)

To prevent abuse of this program, there are these limitations:

- ▶ Each Omaha residence is limited to one 4-part coupon per calendar year .
- ▶ Bulky items must be delivered to River City Recycling.

Cost

- ▶ The resident pays a \$15.00 administrative charge and obtains a 4-part coupon.

- ▶ Coupons may be used immediately.
- ▶ **Small loads:** 4 deliveries (one coupon for each) from automobiles and passenger vans (not to exceed 2 cubic yards).
- ▶ **Large loads:** 2 deliveries (2 coupons for each) from pickup trucks, cargo vans or trailers (not to exceed 5 cubic yards each).
- ▶ **Extra large or heavy loads:** For car, truck, or trailer loads exceeding 1,500 pounds may be charged the scale rate of River City Recycling.
- ▶ **Household Appliances (white goods):** Freon and non Freon appliances (washers, dryers, stoves, water heaters, etc) are not covered by the bulky disposal program
